OLD VOTING RECORDS

Thanks to one of our members, Charlotte Kruse, we have found a new source for finding ancestors. Charlotte obtained much information from the November 8, 1892 Great Register of Nevada County, California. It gave the ancestor's age, physical description, occupation, country of origin, where he lived including which precinct, and when and where (which court) he was naturalized. It also revealed that he registered to vote September 22, 1892.

Using the information that he was naturalized in Nevada County, CA, Charlotte was then able to locate his naturalization card (Form No. 1-1P of the U.S. Department of Labor, Immigration and Naturalization Service). That form revealed where (Volume and Page #, and Court Name) his naturalization record could be found.

Charlotte also mentions that she has used these same naturalization cards in Dubuque, Iowa (1866) and in New Orleans, Louisiana (1865). Thanks, Charlotte for the great tip!

SEAMAN CERTIFICATES

If your American ancestor went to sea in the 1800's he may have applied for a Seaman's Protection Certificate to protect him from imprisonment by Great Britain and other powers. This program lasted from 1796 to 1897. The applicant presented proof of citizenship and paid a fee of 25 cents. Every three months a list of seamen was sent to the Secretary of State, Washington DC abstracting each seaman's age and physical description. STEAM TRAVEL ON LAKE ERIE

Beginning in the 1830's, many of our ancestors migrated to the midwest. Thousands came from Buffalo, New York to Ohio ports across Lake Erie. The following details, abstracted from an 1836 article called "Buffalo Spectator" that appeared in part from the magazine titles "Freshwater", relates some of the facts of Lake Erie travel. "Article follows":

Steamboats carried passengers from May through November making 30 to 34 trips per season. By 1836, twenty-four steamboats regularly operated on the lake between Buffalo and Detroit and Ohio ports. Depending on the boat's size, the number of berths averaged fifty to one hundred fifty. There were two kinds of passage - cabin and steerage. Cabin included meals, lodgings, and all privileges of the boat. Steerage or deck passengers found their own provisions or paid extra for meals at the second table. They slept on deck or occupied the forward cabin which contained berths but no beds or furniture. Multitudes of highly respectable families who were emigrating to the west preferred to take deck passage rather than pay the price of a cabin. Cabin fares ranged from two to eight dollars while steerage was half the price.

CHECKING THE AVERAGES

Tips for researching the pioneering period - before 1850:

- *Figure on three generations per 100 years.
 - *Men's first marriages were about 24, women at 20, usually to someone nearly the same age.
 - *Neighbors married neighbors.
 - *Families and neighborhoods stayed together.
 - *Children were born about a year after marriage.
 - *Subsequent births occurred every two years until age 45.
 - *Women tended to outlive men.
 - *Women rarely moved to another location alone.
 - *Men sometimes returned to a prior residence to find a spouse.
 - *Older widowers liked to marry women much younger than themselves.
 - *Civil War service records can help locate male ancestors born before 1840.
 - *Pioneers moving west generally stayed on a latitude with their own home country.
 - *Consider researching a New England heritage for an ancestor with a "virtue" name like Patience or Silence.
 - *Children often carried on the grandparent's names.
 - *Follow a middle or first name as a link to the mother's or grandmother's maiden names.

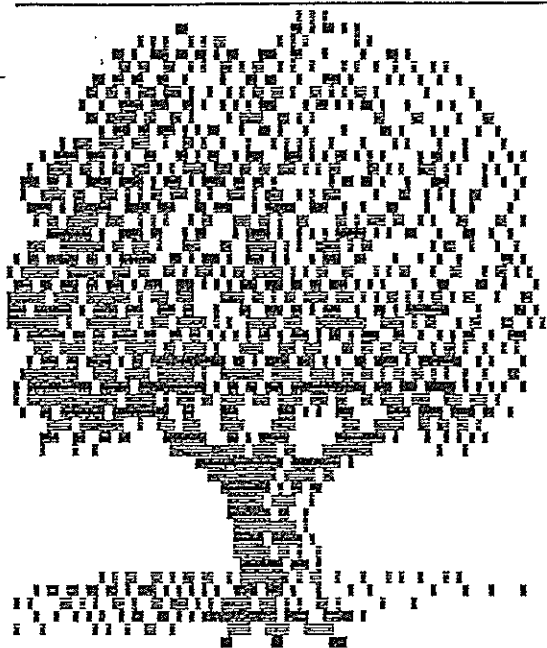
