ARCHDIOCESE OF MILWAUKEE RECORDS

In the Fall of 1993 the Genealogical Society of Utah completed a major microfilming project of Catholic records at the Archdiocese of Milwaukee Archives. Records filmed include pre-1921 sacramental records for all parishes in the ten county area comprising the archdiocese (Dodge, Fond du Lac, Kenosha, Milwaukee, Ozaukee, Racine, Sheyboygan, Walworth, Washington and Waukesha). Span dates of records filmed are circa 1840's-1920. Sacramental records include baptism, marriage, death, first communion and confirmation (not all records exist for all parishes).

The final product of this project consists of 105 reels of microfilm. Use copies of the films are on permanent loan at the Hales Corners Family History Center of the Church of Latter Day Saints (9600 W Grange Ave., Hales Corners, WI 53130. Telephone 414-425-4182). Centers elsewhere in Wisconsin and throughout the country are able to order the films from Salt Lake City.

EQUESTRIAN STATUES

The position of the horse's feet indicates the following: All four feet on the ground indicates that the individual died a natural death. A horse with one hoof raised means that the rider died of wounds sustained in battle. If two hooves are raised it means the rider was killed in battle. This is an international code followed by all sculptors.—from Effingham Co. Illinois Genealogical Society via The Illuminator (Zion Genealogical Society, Zion, Illinois) Vol. 9, No. 1 (1993), p. 19.

d.s.p. Died without issue (decessit sine prole)

d.s.p.l. Died without legitimate issue (decessit sine prole legitima)

d.s.p.m. Died without male issue (decessit sine prole mascula)

d.s.p.m.s. Died without surviving male issue (decessit sine prole mascula superstita)

d.s.p.s. Died without surviving issue (decessit sine prole superstita)

d.unm Died unmarried

d.v.p. Died in the lifetime of his father (decessit vita patris)

d.v.m. Died in the lifetime of his mother (decessit vita matris)
