EAU PLEINE CENTENNIAL

Town of Eau Pleine residents and former residents celebrated the 100th birthday of their Marathon County township with a picnic on July 8 at March Rapids park. A program was held honoring the past and present town officials for their services throughout the years.

Eau Pleine Township was formed in 1884. On September 13, 1884 it was dicided to divide the township of Brighton, and on November 27, 1884, township 27, Range 3 became known as Eau Pleine township.

Edward L. Laessig Sr. was the first elected chairman in the Spring of 1885. He also served as Supervisor from 1904-1906. Records of the township prior to 1904 are missing, so it is unknown who else served on the town board duing the early years.

A photo display provided a look into the past century. Photos in the March and Weber areas depicted early settlers of these communities and some of their livlyhoods including the Doud Lumber Company, an early store, and Pete Weber's Saloon.

Two well-known area history buffs were present, Adella Cline and Clarence Sandgren (who was responsible for the photo display). Both people are walking-talking history books, and are very knowledgable about the people and places of the past and

present. Both live in March Rapids.

A 1975 history booklet of the township was available for sale at \$3.50. It was written by Mr. Sandgren. At this time there is no book being compiled for the centennial, he said.

IDENTITY CRISIS

The following article was found in the Marshfield News-Herald, Wood (County Centennial Edition, August 5-11, 1956:

RIVERS COUNTY ORGANIZATION TURNED DOWN

A move instituted early in 1895 would, had it succeeded, have given Wood county a vastly different geographic area than the 100-year-old county now occupies.

In February of that year, a proposal was advanced to create an entirely new county, to be made up of territory withdrawn from Hood, Clark and Marathon counties.

The tentative name chosen for the proposed new unit of government by its advocates was "Rivers county."

The plan, as reported in the newspapers of that day, was to take Harshfield, Lincoln and Auburndale townships, the village of Auburndale and the city of Marshfield away from Hood County and link them with 10 townships withdrawn from Harathon and six from Clark.

The proponents sent a delegation of 18 representatives to a meeting in Grand Rapids on Feb. 15 to present their case to the Businessmen's Assn. of Grand Rapids and Centralia.

Speaking on behalf of the proposal for creating the new county were B.W. Pulling, John F. Cole, John P. Hume and H.A. Lathrop of Marshfield and B.R. Salter and Samuel Shafer of Colby.

The Grand Rapids and Centralia spokesmen, who argued strongly against what they termed the "secession" movement, included L.H. Wash, George L. Williams, J.A. Gaynor, G.R. Gardner and J.D. Witter.

They pointed that the territory proposed to be withdrawn from Hood county had a valuation (for tax purposes) of \$490,000, or approximately 24.5 per cent of the total valuation of the county, and a population comprising roughly one-fourth of the county's total populace.

The opposition speakers further emphasized, according to a newspaper report of the meeting, that "Hood county is now 72 square miles short of the size fixed by the state constitution that is not to be changed without a vote of the people."

Gardner, Witter and Williams were appointed as a committee to prepare a formal statement representing the Grand Rapids-Centralia attitude toward the idea of reducing the size of the county. On Feb. 18 this committee posted a letter to the Businessmen's Assn. of Marshfield, stating that "the people of said cities are unanimously opposed to said proposition, or to any proposition which would detach any of the present territory of Wood county or change the boundaries thereof".

Speaking editorially on the subject the Centralia Enterprise observed:

"The Enterprise has nothing but admiration for the push, the splendid go-ahead-iveness, and the business enterprise of the citizens of Marshfield. In that respect they have set a pace which it would be well for the twin cities to follow. To a man they take pride in their city, and are untiring to further and advance its interests. At the same time, the Enterprise does not believe that the proposed division will be for the best interests of Hood County."

Apparently the whole matter of carving out a new county in central Hisconsin was laid to rest after the Hood County Board voted, 20 to 11, to memorialize the State Legislature to oppose any change in the county's boundary lines.

A search of subsequent files fails to reveal whether the issue ever reached the Legislature for action.

The first mention of this new county was found in the MARSHFILED TIMES AND GAZETTE on April 19, 1884. It is interesting to note that people of this area, 100 years ago, were talking about the special needs of the same area that was chosen by the Marshfield Area Genealogy Group. Even that long ago, this area felt the need to join together because of similarities in lifestyles and needs.

Had this movement been successful, our group would probably been the RIVERS COUNTY GENEALOGY GROUP. It would be nice to incorporate this information in our group somehow. If anyone has any suggestions as to how we can do this without it being confusing, please let us know.

MARATHON COUNTY PUBLIC LIBRARY CENSUS HICROFILM RENTALS

Marathon County Public Library, can obtain through the interlibrary loan program, copies of all Federal census schedules (1790-1910) and the soundex, A person wishing to rent census microfilm should stop at the Library's reference & information desk. Catalogs detailing census schedules are available there.

The library will place orders for the reels of microfilm requested by the user. Length of rental for the film is seven days. The cost per reel is \$2.25. Overdue charges of \$2.25 are assessed if the film is returned more than two days after the designated return date. Payment must accompany each order, and the checks should be made payable to the Census Microfilm Rental Program.

Customers may order film to be delivered on a specific date or they may request film to be shipped "as soon as possible." The microfilm is delivered to the Marathon County Public Library and must be viewed there.

Feb. 11, 1909 MAKE APPLICATION FOR NATURALIZATION PAPERS

Under the new naturalization laws which are much more stringent than formerly, men who have neglected taking out their second papers or declaring their intention to become citizens are hurrying now to comply with the new law. Friday of last week Clerk of Court Bever and Attorney Charles Breier came up from Grand Rapids and conducted a school for naturalization at the city hall. Eleven were present to make application for second papers and three who filed papers of declaration to become citizens. Following is the list: Michael Troiber, August Hachalski, Joseph and *Henzel* David, Ludwig Binder, Michael John Kiesling, Hilliam 🛚 Reichert, Hels Nelson, H.F. Thiel and Max Schmidt, second papers and Hichael Kellner, Abraham Aronson and Louis Ancell, first papers.

June 3, 1909 MANY TAKE DUT NATURALIZATION PAPERS

Under the new naturalization laws many are availing themselves of the opportunity to become full citizens. On Tuesday of this week Judge Hebb made it a special order of cour, 66 making application of which 62 received their papers, two being continued and denied. Those from this city and adjoining towns who received their papers were Mike Schmidt, D. Marx, Franz Stuber, Jos. Koholka, August Michaelski, Henzel Robl, Hels Nelson, Wm. Reichardt, town of Harshfield; Joseph Bowman, Joseph Kiesling town of Cameron; H.F. Thiel, Ludwick Binder, Hike Ertl, Nels Kr. Christensen,

Christensen, Mike Froiber, town of Lincoln; Alois Youngswirth, Joseph David, Hendolin David, town of Rock; Alex La Point, Marshfield city. Hon. R.S. Coleman of St. Paul, U.S. attorney for a district of states, conducted the examinations.

PETITION OR APPLICATION FOR PROBATE

Most of us are aware of the value of the probate package but in the last few years another document has been brought to my attention, the "petition or application for probate." This is probably the most valuable document, after the will, to be found at the county courthouse because the probate laws in most states required that this document include the names, ages, addresses and relationship to the deceased of all heirs whether mentioned in the will or not.

The Researchers Guide to American Genealogy by Val D. Greenwood, pages 227 and 245, puts it this way: "The will is ordinarily brought before the Court of proper jurisdiction to be probated by the filing of written application or petition for probate. In more recent years, in the states which require them, these applications have proven to be invaluable genealogical documents as they must include names of all next-of-kin

of the testator, relationship or degree of relationship to him (with ages of minors) and post office addresses.".

If an individual dies intestate, the requirements are much the same: "No court can acquire juridiction unless there is proof of death. Probate proceedings are usually set in motion by a petition...the 'amount of property...and, in more recent years the names and relationships those persons who may be entitled to share in that property..."

What a genealogical gold mine these applications for probate can be!
